- 2.Cut section: Endo-myometrium measures 3 mm and 2 cm in thickness respectively.
- 3.An endometrial polyp is present, measuring 0.6x0.5x0.2 cm.
- 4.A small intramural fibroid is present, measuring 0.9x0.7x0.5 cm.
