Uterus with cervix measures 10x8x5 cm.

1. Cervix measures 2 cm in length.
2. Cut section: Endo-myometrium measures 2 mm and 2.4 cm in thickness respectively.
3. Upon sectioning, myometrium appears trabeculated.

Right adnexa

1. Ovary measures 1.5x1x0.8 cm.
2. Fallopian tube measures 4 cm in length and 0.5 cm in diameter
3. Cut section: Unremarkable

Left adnexa

1. Ovary measures 2x1x1 cm.
2. Fallopian tube measures 4 cm in length and 0.5 cm in diameter
