#### GROSS EXAMINATION:

1. Received (in formalin) two whitish soft tissue fragments, aggregate measuring 0.4x0.3x0.2 cm.
2. Entire tissue is submitted for processing in 1 cassette.

#### MICROSCOPIC EXAMINATION:

Sections examined show gastric antral mucosal fragments.

- There is distortion of foveolar architecture.
- There is dense chronic lympho-plasmacytic inflammatory infiltrate admixed with scattered eosinophils in lamina propria.
- No neutrophilic activity is present.
- No atrophy is noted.

- There is no evidence of granuloma, intestinal metaplasia, dysplasia or malignancy.
- Small curvilinear bacilli are present in the mucus clinging to the foveolar epithelium, morphologically suggestive of Helicobacter pylori.

### INTERPRETATION/RESULT:

Severe chronic antral gastritis without activity.

H. Pylori organisms present.

Remarks: Recommended correlation with clinical, endoscopic and H. pylori serological investigation findings
