TISSUE BIOPSY LARGE

GROSS DESCRIPTION

Received specimen of right breast lump in formalin container labeled with two identifiers. It consists of lobulated fibro fatty tissue of breast parenchyma measuring 8.0 x 5.0 x 3.6 cm in size. Cut section shows irregular, firm, grey white area extending throughout the mass and reaching upto cut margins. Representative sections are taken in 05 blocks.
A1 to A5-grey white mass with margins

MICROSCOPIC DESCRIPTION

Multiple sections from the lump show anaplastic ductal cells infiltrating the stroma. These ductal cells have large, pleomorphic nuclei and some show nucleoli. Comedo- necrosis seen.

Right breast

Surgical Procedure: Wide Excision Rt breast lump
Lymph Node Sampling: Nil
Tumor Site: irregular tumour mass seen throughout the wide excision tissue.
Histologic Type: **Invasive mammary carcinoma of no special type (ductal, not otherwise specified)**
Histologic Grade (Nottingham Histologic Score)
Glandular (Acinar)/Tubular Differentiation- Score 2 (10% to 75% of tumor area forming glandular/tubular structures)
Nuclear Pleomorphism- Score 2 (cells larger than normal with open vesicular nuclei, visible nucleoli, and moderate variability in both size and shape)
Mitotic Rate - Score 1 (3 mitoses per mm²)
Overall Grade = Grade 2 (scores of 6 or 7)
Venous/Lymphatic Invasion: Present
Ductal Carcinoma in Situ (DCIS): **Comedocarcinoma** present
Resection margins- Tumour reaches upto the margins
Primary Tumor (pT): **pT3**: (Tumor >50 mm in greatest dimension)
Regional Lymph Nodes (pN): pNx, Metastasis (pM): pMX

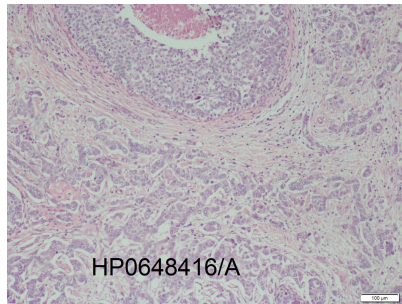


