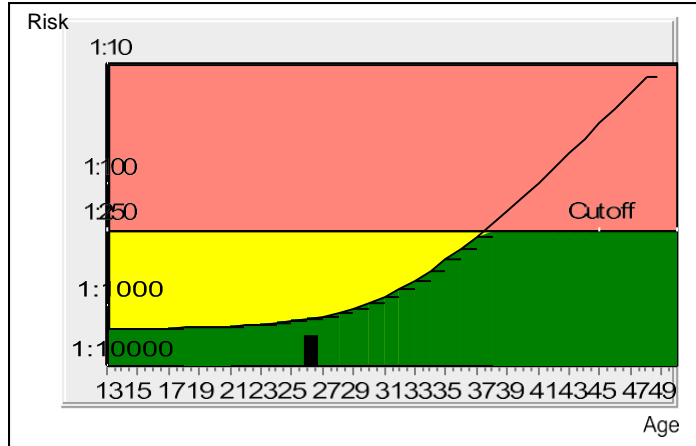

For MRS. AMARJEET , born on 02-12-1994, a screening test was performed on the 28-05-2019. Prisca screens for Trisomy 21, Trisomy 18 and Neural tube defects (NTD).		TRISOMY 21 SCREENING The calculated risk for Trisomy 21 is below the cut off which represents a low risk. After the result of the Trisomy 21 test it is expected that among 3785 women with the same data, there is one woman with a trisomy 21 pregnancy and 3784 women with not affected pregnancies. The calculated risk by PRISCA depends on the accuracy of the information provided by the referring physician. Please note that risk calculations are statistical approaches and have no diagnostic value!
