## **Down's Syndrome Risk**

The calculated risk for Trisomy 21 is below the cut off which represents a low risk.

After the result of the Trisomy 21 test it is expected that among 4305 women with the same data, there is one woman with a trisomy 21 pregnancy and 4304 women with not affected pregnancies. The calculated risk by PRISCA depends on the accuracy of the information provided by the referring physician.
